



Resurrecting the Napier War Memorial

Applause rang out at a Napier City Council meeting yesterday, after it resolved to "get this right" on the Napier War Memorial.

This has been embroiled in a months-long emotional saga, after the council agreed to remove commemorative items from the Napier Conference Centre during its multi-million dollar redevelopment, to be installed in a more appropriate location- moves not widely known by the public.

There has since been widespread upset, particularly as the building was built through public funding to be a memorial.

Speaking to his 840-signature petition at the start of the meeting, resident Selwyn Hawthorne appealed to Napier mayor Bill Dalton to make decisions "that will allow you to have a clear conscience when you say 'lest we forget'".

If the council voted to restore the memorial items, and "consult openly and meaningfully with the community regarding the return of the correct name of the building, you will be remembered, hopefully for the right reasons."

His appeal appears answered - yesterday council unanimously agreed to reinstall the items at the Floral Clock site, and to consult with the community on the process going forward - including memorial design concepts, the roll of honour plaques, and the building's name.

This consultation was included in five new recommendations put forward by councillor Kirsten Wise.

"The message I have received loud and clear is that [the community] are unhappy with the decisions that have been made," she said.

"It is our responsibility I believe as elected representatives to consult and listen to what our community is telling us, and I don't believe we should be rushing into any decisions going forward.

"We need to get this right, and we need to get the whole of our community and certainly stakeholders such as Guy Natusch, the original architect of this building, involved."

This was echoed by deputy mayor Faye White, who said "sometimes we need to undo our mistakes".

"Today is about putting right what has gone wrong. We didn't start off to make it wrong but unfortunately it did go wrong."

When asked if the new recommendations had any disadvantages, Napier Mayor Bill Dalton said undertaking a full consultation process would take time, and would add to the workload of staff, who were

already working on other "major" consultation processes.

In response, Ms Wise said she appreciated people wanted the memorial back, but time was not an issue.

She understood once the design concepts were completed consultation could begin - which could occur in the new year.

Cheers rang out from the 20-person audience when council agreed to include the new recommendations.

It was known the council would restore the memorial items, however some remained upset about "War Memorial" being removed from the Napier Conference Centre title as they saw the building and memorial as linked.

Ms Wise's recommendation would see the building's name consulted on. The original recommendation was to rename the centre's ballroom as the "War Memorial Hall".

It was also suggested this name could be restored on the outside of the centre directly above the new memorial site, although Napier Conference Centre would be used for branding.

The new recommendations also meant the existing roll of honour plaques would remain in storage until the community were consulted on how they could be incorporated into the new memorial.

And, additional funding would be allocated to the project once design concepts and project costs were completed. About \$50,000 had been allocated for the relocation of the war memorial.

The floral clock would be relocated to the sunken gardens. The Hurst family had been consulted and had agreed with that.

Update - 18 November: Guy Natusch has submitted a design; Council will be consulting the public next year on the matters agreed upon. Editor.



Councillor Comment *Maxine Boag*



AS I write this, my Council calendar over the next month is full of seminars and presentations, meetings, farewells, AGMs, Xmas events with highlights like the Grey Power Xmas luncheon.

Preparing to produce the Draft Long Term Plan (LTP) for distribution and wide consultation next year has been a focus of much extra Council time. Our LTP 2018-2028 will give us clear direction for the next three years. We have many issues and projects to consult on, such as the new Aquatic Centre, the planned Aquarium, the Civic and Library buildings, Park Island, the War Memorial, the Ahuriri Estuary Master Plan, water security, McLean park, courts at PGA to mention some. Over the next few weeks we will be deciding what goes into the Plan, which requires us to work closely as a team.

The housing crisis continues to ramp up, with the latest figures showing the quarterly Social Housing waiting list numbers in Napier increase by 28 per cent in the last three months. People seeking affordable rental accommodation are in very dire straits, both young and old. An upcoming review of Council's social housing will no doubt take this into consideration, as it affects the well being of a large number of our citizens.

The increase in beggars and homeless people has become obvious in Napier, and we have all been scratching our heads as to what to do. Cr Tapine and I attended a retailers meeting at Marewa, along with the Mayor, staff members and the police. I believe that a combination of more social housing and support, along with asking shoppers not to pay or feed them would have better outcomes for all—beggars, shoppers and retailers. Long term solutions need to be found with both Central and Local government and NGOs working with the community.

With my getting elected on the Age Concern Board, along with being Publicity Officer for Napier Grey Power, and Council rep on the HB Positive Ageing Trust, I feel well positioned to support older people in both the community and in public office.

I will be away in January, but hope you all have a fabulous Xmas and New Year!

Some sound advice

"Be prepared" was the overarching message from our two speakers at our October meeting: Katherine Dunstall, Funeral Director from Dunstalls Funeral Services, and lawyer Paul Morgan, Carlile Dowling.

Young, capable and enthusiastic, Katherine expressed her pride as representing the fourth generation of Dunstalls caring for Napier families.

She challenged us by reminding us that we prepare for many things in our life: for holidays, for birthday parties and Xmas, for work, retirement, children and grandchildren.

But are we prepared for our funeral? Cremation? Burial? Church? Chapel? Marae? What do you want said when you've gone? Arranging a loved one's funeral can be an extra burden on family and friends. Having a **funeral plan** will lessen their responsibilities at what is likely to be a difficult time.

Katherine pointed out that while some people choose to have no service, they miss out on something that may help the family with the loss.


"That final goodbye can be very simple but still hold onto the spirit that is needed to share how special your life has been, to share the stories that can fill that sadness left when someone passes away," she said.

Katherine gave out Dunstalls' Funeral Care Packs - go see them if you want to take this step.

Will power

Paul Morgan stressed on us the importance of having a will as well as a Funeral Plan. Your will determines who is in charge of managing the distribution of your estate and belongings when you die.

If we die without a will, the provisions of the Administration Act 1969 take over to determine what happens to the estate.

For example if you die intestate (without a will) and you have a partner/spouse, as well as children, the partners will get \$155,000 plus 1/3 of the rest of the estate, with 2/3 going to children/grandchildren). Not what you'd expect!

When is the right time to make a will? Now, while you are still mentally capable. "Do your loved ones a favour by making sure they are not left with an administrative mess!" Paul said. "You will feel much happier and satisfied once you have put in place arrangements which look after the ones you love."
